COMPATIBILITY

A jar compatibility test is recommended before mixing with any product other than water in the tank to insure compatibility with foreign spray mixes. Not compatible with High concentrated Calcium, phosphate or carbon.

APPLICATION

LAWNS, GREENS AND TEES: Apply at a rate of 3-8 oz per 1,000 sq. ft every 2-4 weeks, depending on your turfs needs.

FAIRWAYS: Apply 4-6 oz per 1000 ft 2 apply every 2-4 weeks.

AGRICULTURE: For row crops apply at the Flowering and fruiting stage at a rate of 1 quart per acre with sufficient water to cover the foliage to point of runoff.

GARDENS: Apply 2 oz of spray for each gallon of water and apply until foliage is wet. Apply no later than 1 week before flower and as early as the three leaf stage. Apply every month or as needed.
