Re-Energizer™ is specifically designed to energize your turf and soil to its optimum nutrient levels.

This should be used in conjunction with a regular fertilization program to maintain maximum health, growth and color.

STORAGE

Keep container sealed tightly when not in use. Do not expose to sunlight for long periods of time. Store in temperatures between 5 C (41 F) and 25 C (77 F).

MIXING INSTRUCTIONS

Re-Energizer™ is compatible with most fungicides, pesticides and other liquid fertilizers and could help intensify fertilizers. Care should be used when mixing fertilizers at full strength with this product to avoid burn.

A jar compatibility test is recommended. Follow this mixing sequence:

1. Water
2. Re-Energizer™
3. Pesticides
4. Fertilizers

DISCLAIMER

It is recommended not to use this product with fungicides or pesticides. However, if applied with a fungicide or pesticide, it is the user's responsibility to conduct a trial application on the crop(s) to be sprayed with this mix of chemicals to determine compatibility of products and compatibility with crop(s) sprayed. COMPATIBILITY

A jar compatibility test is recommended before mixing with any product other than water in the tank to insure compatibility with foreign spray mixes. Not compatible with High concentrated Calcium carbon, phosphate or low pH mixes.

APPLICATION

TURF, GREENS AND TEES: Apply 6 ounces per 1,000 sq. ft. as a foliar spray every 2-4 weeks.

FAIRWAYS: Apply 4-6 ounces per 1,000 sq. ft. Every 2-4 weeks.

FERTIGATION: Apply 4-6 ounces per 1,000 sq. ft. fertigation as needed.

ORNAMENTAL, PLANTS, SHRUBS AND TREES: Apply at a rate of 2-4 quarts per 100 gallons of water as a foliar spray and repeat as needed.
